We welcome you to NWG Financial Services, our initial obligation at the start of the relationship is to fully inform you of your rights, entitlements and detail the services we provide. This Financial Services Guide (FSG) is intended to inform you of certain basic matters relating to your relationship with our Authorised Representative and with us, prior to you being provided with any authorised financial service. Subjects referred to in this FSG disclose who we are, contact details for ourselves and our Authorised Representative, how we and our Authorised Representatives are remunerated and the method by which we engage our professional advice process. It is intended that this document should assist you in determining whether to use any of the services described. It is our duty to provide you with this document at the first available opportunity.

Who will be providing the financial services to me?

Wayne Kampen and New Wave Financial Planning Pty Ltd t/a New Wave Financial Planning are Authorised Representative No 1266195 and Authorised Representative No. 1284550 (respectively) acting under authority from NWG Financial Services.

Statement about non-independence

We are obliged to tell you that under the Corporations Act, we are prevented from using the terms independent, impartial and unbiased as both my Licensee and I receive commissions for the advice that we provide on life insurance products and may also charge fees based on the amount of money invested.

Getting Started

Q. Who is your Adviser?

Your adviser will be Anthony Cerantonio and New Wave Financial Planning who are authorised to act on behalf of NWG Financial Services.

Anthony started providing financial advice to clients in 2016 - Prior to this, he had years of experience in public practice and is also qualified as a Chartered Accountant - His passion is giving clients the confidence and advice to assist them in preparing for and transitioning to retirement and ensuring they have the money they need to support their desired lifestyle

Anthony is also passionate about assisting younger clients to generate wealth

Anthony has completed a Bachelor of Commerce (Accounting) at Griffith, is a Chartered Accountant and holds a Graduate Diploma in Financial Planning.

Q. Who is responsible for the advice given to you?

NWG Financial Services is responsible for the financial services provided to you.

Provision of Advice

Q. When will you receive a Statement of Advice?

You are required to receive a Statement of Advice whenever our Authorised Representative provides you with personal advice which takes into account your objectives, financial situation and needs. This Statement of Advice will contain the basis on which the advice is given, personal information, recommendations and information about fees, remuneration and associations which may have influenced the provision of the advice.

Thereafter, if your circumstances have not significantly changed our Authorised Representative can provide you with another Statement of Advice or a Record of Advice as a confirmation of the advice provided. You are able to request a copy of these documents at any time up to a period of seven years.

Product Disclosure Statement

When our Authorised Representative makes a recommendation to acquire a particular financial product, you must also be provided with a Product Disclosure Statement from the issuing product provider which gives full details of the recommended product to assist in making an informed decision to acquire that product.

Q. How will you pay for the services provided?

A fee may be charged for our services. This may be waived or partially offset by brokerage, commission or fees if you proceed. Upon implementation of the recommendations, our Authorised Representative may receive an upfront fee, commission (for risk insurance products) or a combination of both depending on how you agree to pay for the services. Fees can be based on total funds placed, the time spent on the services you receive, or as agreed between you and our Authorised Representative. Costs and remuneration will be disclosed in your Statement of Advice.

All fees and commissions are paid to NWG Financial Services, which deducts a fee for the services it provides as the licensee and then pays the balance to your adviser subject to any agreements. Some of our Authorised Representatives have referral arrangements with other professionals. Where a referral agreement is in place between the Authorised Representative and a third party, a fee may be paid or received. Detailed disclosure of amounts and percentages will appear in your Statement of Advice if applicable.

A review service fee may also be payable from time to time, depending on any extra work required such as a major restructuring.

Life Insurance advice

If you decide to purchase a life insurance product, unless stated to the contrary in your Statement of Advice, NWG Financial Services has elected to receive commission from the product providers and not invoice you directly for services provided. If you do not continue with a purchased life insurance product for a full 24 months, the commission received by NWG Financial Services is returned to the insurance company, and you may then be invoiced for this amount.

Investments and Superannuation advice

If you decide to proceed on the investment or superannuation advice provided, the fee you may be charged may be dollar based or may be calculated as a percentage of the amounts invested. The fee may also be an hourly rate.

What kinds of financial services are you authorised to provide me and what kinds of products do those services relate to?

Kaite Cover is an employee of New Wave Financial Planning and is authorised to act on behalf of NWG Financial Services to offer you the following services:

- Provide financial product advice and
- Deal in a financial product by arranging for a financial product to be acquired, disposed of, or varied.

Anthony Cerantonio can provide advice on and deal in the following products:

- Deposit and Payment Products (basic & non-basic)
- Government Debentures, Stocks or Bonds
- Life insurance investment products
- Life risk insurance products
- Interests in managed investment schemes (incl IDPS and managed discretionary accounts)
- Retirement savings accounts
- Securities
- Superannuation (including SMSFs)

We will only recommend a product or strategy to you after considering its suitability for your individual situation and needs. We do not provide advice in any other area of insurance or investments but can refer you to a professional who specialises in other areas if requested. Any arrangements you make with the other professional will be strictly between you and that person and neither NWG Financial Services nor our Authorised Representative accept any responsibility or liability for the advice given.

Do you receive remuneration, commission, fees or other benefits in relation to providing the financial services to me and how is that commission calculated?

New Wave Financial Planning will be paid 100% of the brokerage, commission and/or fees received by NWG Financial Services minus a fixed monthly fee for the provision of professional services from NWG Financial Services. This brokerage/commission/fee is used to provide income after paying for the normal expenses incurred with running a business (e.g. rent, vehicle, computer, stationery, professional fees etc.).

Kaite Cover receives a salary from New Wave Financial Planning, the salary is based on experience and capability.

Insurance Monitoring:

Internal databases are maintained detailing client's insurances that were recommended by our Authorised Representative on behalf of NWG Financial Services. This does not constitute portfolio monitoring.

How we charge for our services

Unless otherwise stated, all fees and commission are inclusive of GST and the fees could be greater than those disclosed below in complex cases. In these instances, we will inform you of the exact fee payable promptly in writing.

Investment advice – Initial and Ongoing

We may charge you an agreed fee for investment-based advice which will be either a fixed fee, based on our hourly rates or a percentage of the assets you invest.

- Initial consultation – at no cost to you
- Advice preparation and Implementation fees – will depend on complexity of your circumstances and may range up to \$9,900 for each fee
- Ongoing or Fixed Term advice fees – can generally range up to \$9,900 each year. Services Outside of scope may be charged at a higher rate
- Ad hoc advice hourly rates range up to \$440

We will seek your consent before charging any fees in this manner.

Insurance - Initial (Commission on Life Insurance Products)

The relevant insurer will pay initial commission based on a number of factors, including the annual premium, loadings which apply to the premium (such as medical or payment frequency loadings), and any policy or other fees. These factors will vary between insurers.

The following ranges will apply (all figures are exclusive of GST and other taxes/statutory charges):

- 66% for applications made from 1 January 2020.

e.g. we would be paid \$660 commission for a \$1000 policy. Commission is paid to us by the product provider and is not an additional cost to you.

Insurance - Ongoing (Commission on Life Insurance Products)

Annual commission will be paid when you renew your policy each year.

- The rate of ongoing commission is between 0% and 33% of the annual policy cost for as long as you hold the product.

e.g. we would be paid up to \$330 commission for a \$1000 policy. Commission is paid to us by the product provider and is not an additional cost to you.

Commission may also be paid on the basis of increases in sum insured under your policy. This commission will be calculated on the same basis as initial commission (see above) and will vary depending on the insurer.

Before receiving Advice

Q. Will we provide you with advice suitable to your needs and financial circumstances?

Yes. In order to provide quality advice you need to supply us with your individual objectives, financial situation and needs. You have the right not to divulge this information; if you do not wish to do so then we are required to warn you about the potential consequences of us not having your full personal information prior to providing advice. You should read the warnings carefully and ask our Authorised Representative of these consequences if you are not sure.

Q. What should you know about the risks of the financial products or strategies we recommend to you?

Our Authorised Representative will explain to you any significant risks of financial products and strategies which are recommended to you.

Q. What information do we maintain in your file and can you examine your file?

Our Authorised Representative will maintain a record of your personal profile, which includes details of your objectives, financial situation, needs, copies of recommendations made to you and any product acquired by you. If you wish to examine your file, we ask that you make a request in writing and allow up to fourteen (14) working days for the information to be forwarded. You may be charged a fee to cover the cost of verifying the application and locating, retrieving and copying any material requested. If the information sought is extensive, you will be advised of the likely cost in advance and can help to refine your request if required.

Conflicts of Interest

NWG Financial Services and our Authorised Representative may receive additional benefits from product providers we deal with such as:

- Contributions to our training and education budget, used for making available professional development to our Authorised Representatives, and/or
- Small gifts or entertainment.

Any additional benefits are not permitted to be paid to our Authorised Representative if they are as a result of, or conditional on, the amount of business an Authorised Representative gives to a product provider.

NWG Financial Services holds no interest in or investments in any product provider. NWG Financial Services has put measures in place to ensure that these additional benefits will not influence any financial product advice provided by NWG Financial Services Authorised Representatives.

Wayne Kampen is a common director and shareholder to NWG Financial Services and New Wave Financial Planning, so may receive benefits such as dividends. New Wave Financial Planning may provide financial assistance to NWG Financial Services in the form of a loan from time to time.

What financial services are offered?

Dispute Resolution

Q. Who can you complain to if you have a complaint about the provision of financial services to you?

If you have any complaints about the service provided to you, you should take the following steps:

1. Contact your Authorised Representative and tell them about your complaint.
2. If your complaint is not satisfactorily resolved within three working days, or you would prefer not to contact your Authorised Representative, please contact the Complaints Manager at NWG Financial Services via any of the following methods:

3. NWG Financial Services will endeavor to resolve all complaints within 30 days of lodgment. Should there be special circumstances relating to the complaint, such that it is not reasonable for the complaint to be resolved in that time, NWG Financial Services will inform the complainant of the reasons for the delay. We may request an extension of time up to a total of 90 days.
4. If NWG Financial Services has not responded within 30 (or 90) days or you are not satisfied with the response, you can lodge a dispute with the Australian Financial Complaints Authority. This service is provided to you free of charge.
